2009/2010 Season Pass Application

Season passes are on sale for \$195.00 per person until 10/10/2009, \$215.00 per person until 11/30/2009. Starting 12/01/09, passes will cost \$270.00.

Tanglwood Ski Area, Inc. Season Pass Policies & Regulations:

1. Season passes are valid during the 2009/2010 season and will expire after the close of the current season.
2. Season passes are non-transferable and can not be used by anyone other than the person issued to under any circumstances.
3. The misuse of any type pass or photo ID that allows for ski privileges will result in fine, loss of ski privileges and/or possible criminal prosecution for theft of services.
4. Season passes must be clearly visible at all times to lift personnel. Passes must be worn above the waist.
5. Management reserves the right to revoke any passes for failure to comply with the Skiers Responsibility Code, foul language, and/or disorderly/destructive behavior on all Tanglwood Ski Area property.
6. A lost season pass must be reported to the Main Office immediately. Replacement cost is \$20.00.
7. The season pass offer is not valid for snow tubing.

Hours of Operation:

Season passes are valid anytime that Tanglwood is in operation for the ski season. All operating days are weather dependent. The tentative Ski Season is Mid December to Mid March. Operating hours are Closed Monday, Tuesday & Wednesday. Thursday, Friday & Saturday 9am-9pm, and Sunday 9am-5pm. Tanglwood will be open on Monday, Tuesday & Wednesday of Holiday weeks 9am-5pm. These hours are subject to change without notice due to unseasonable weather.

Refund/Transfer Policies:

1. All season pass purchases are final. There are NO REFUNDS.
2. There are no refunds for any reason including, but not limited to sickness, injury, health problems and weather conditions.
3. If a pass holder would like management to consider a transfer of the pass to the following year they must have the request in to the main office by February 3, 2010.
4. Season pass transfers will only be made for medical reasons accompanied by a doctor's verification letter.

Release of Liability-PLEASE READ

I understand and accept the fact that alpine skiing in its various forms is a hazardous sport that has many dangers and risks. These risks include but are not limited to, variations in snow, ice and icy conditions, steepness and terrain, moguls, rocks, bare spots, lift towers, poles, snowmaking equipment and component parts, trail fences and the absence of such fences and other forms of natural or man-made obstacles or other skiers. Trail conditions vary constantly because of weather changes and skier use. I realize that injuries are a common and ordinary occurrence of this sport. I agree, as a condition of being allowed to use the ski area facility and premises, that I freely accept and voluntarily assume all risks of personal injury or death or property damage, and release Tanglwood Ski Area, Inc. and its agents, employees, directors, officers, and shareholders from any and all liability for personal injury or property damage which results in any way from negligence, conditions on or about the premises and facilities, the operations of the ski area including, but not limited to grooming, snowmaking, ski lift operations, actions or omissions of employees or agents of the area, or my participation in skiing or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

I, the undersigned, have read and understood the terms of the above Season's Pass and the Release Agreement which is an essential part of it. I am signing it freely and of my own accord, realizing it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, that I have full authority to do so, realizing its binding effect on them as well as myself.

As a condition of holding a Season's Pass identification card and being permitted to use any and all of the facilities of the ski area, I further agree to assume all risk of personal injury or loss or damage to any of my property.
